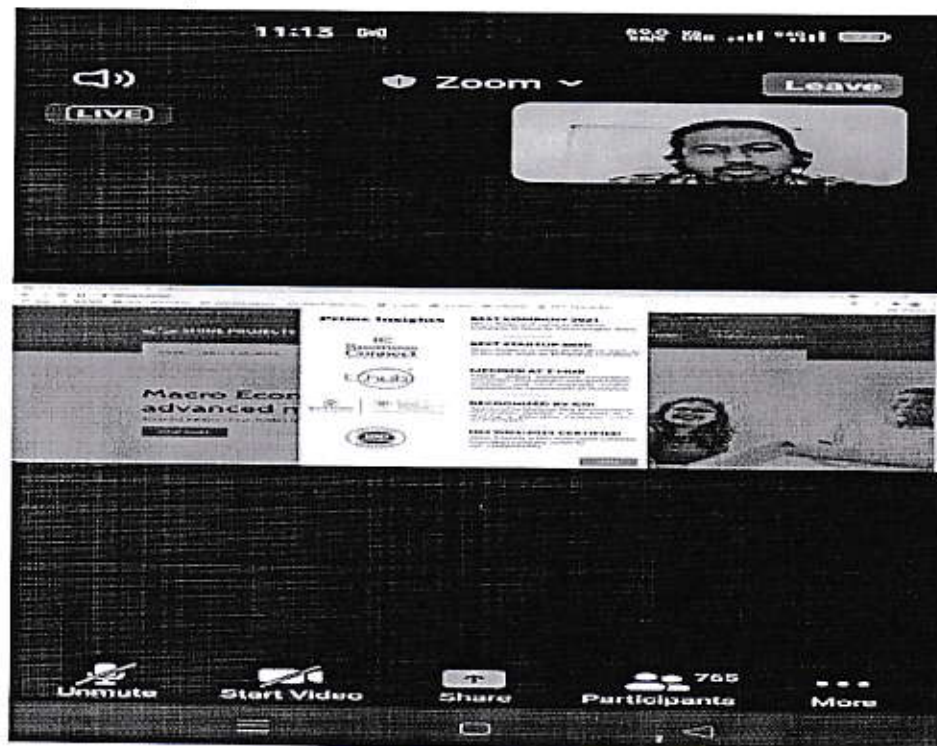


Outcome: -
