4. They understand the importance of the Worldwide Resurgence of Economy.



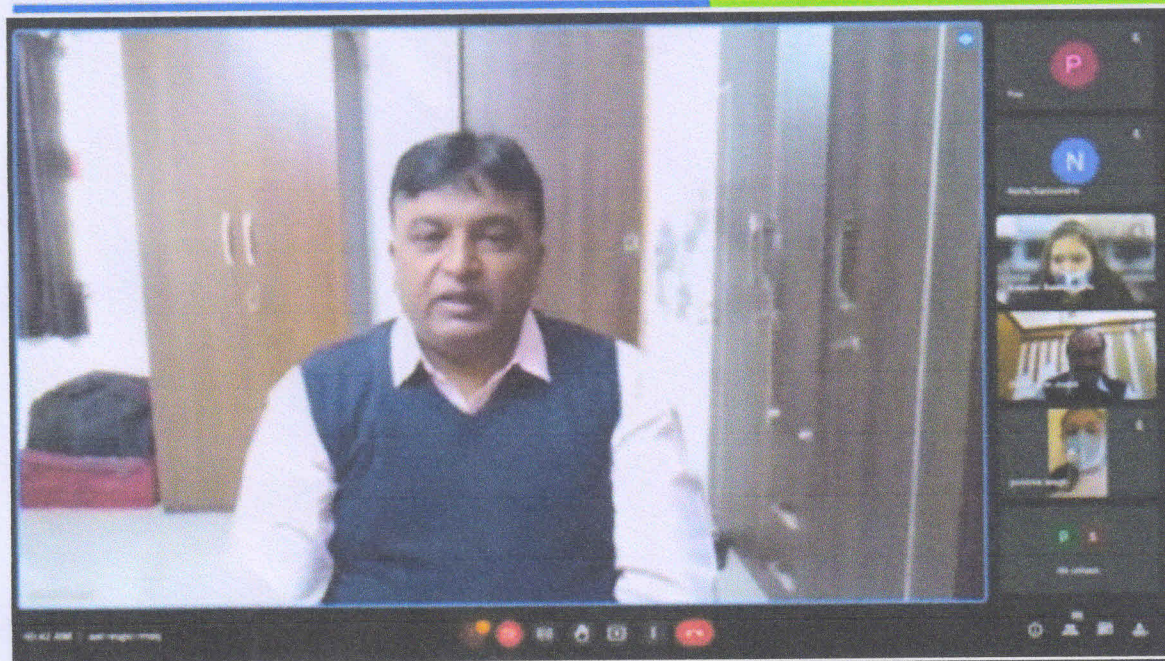
5. The Participants also expanded their knowledge about Worldwide Resurgence of Economy after the Pandemic

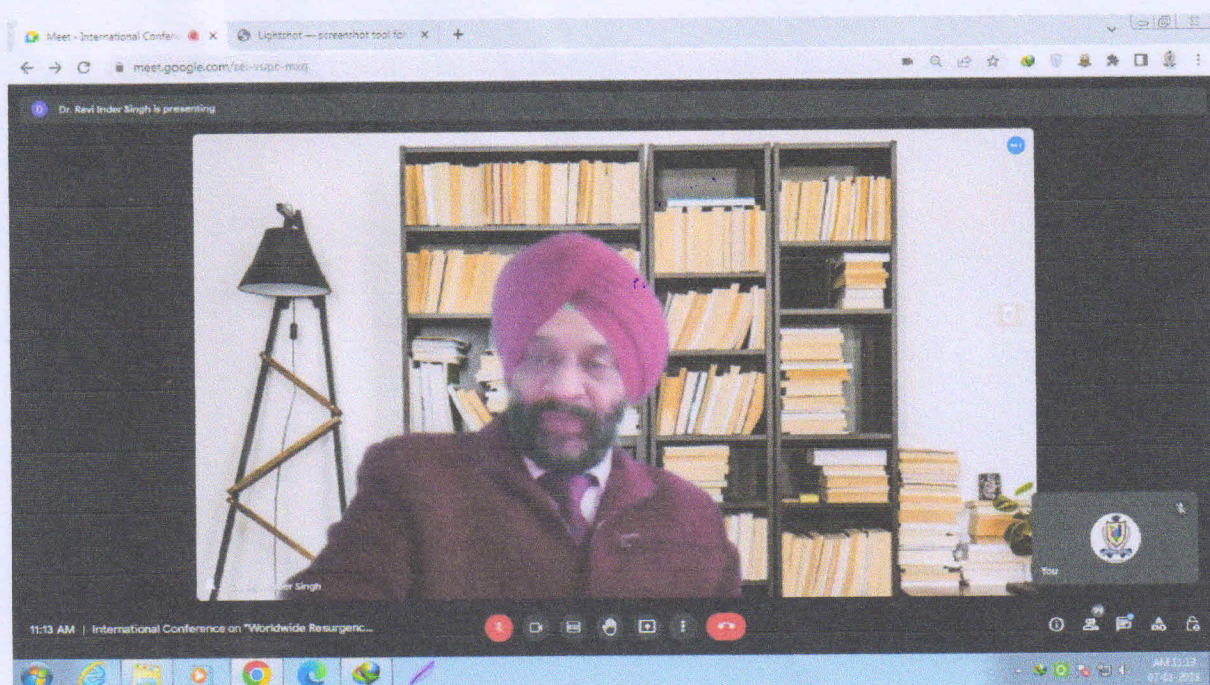

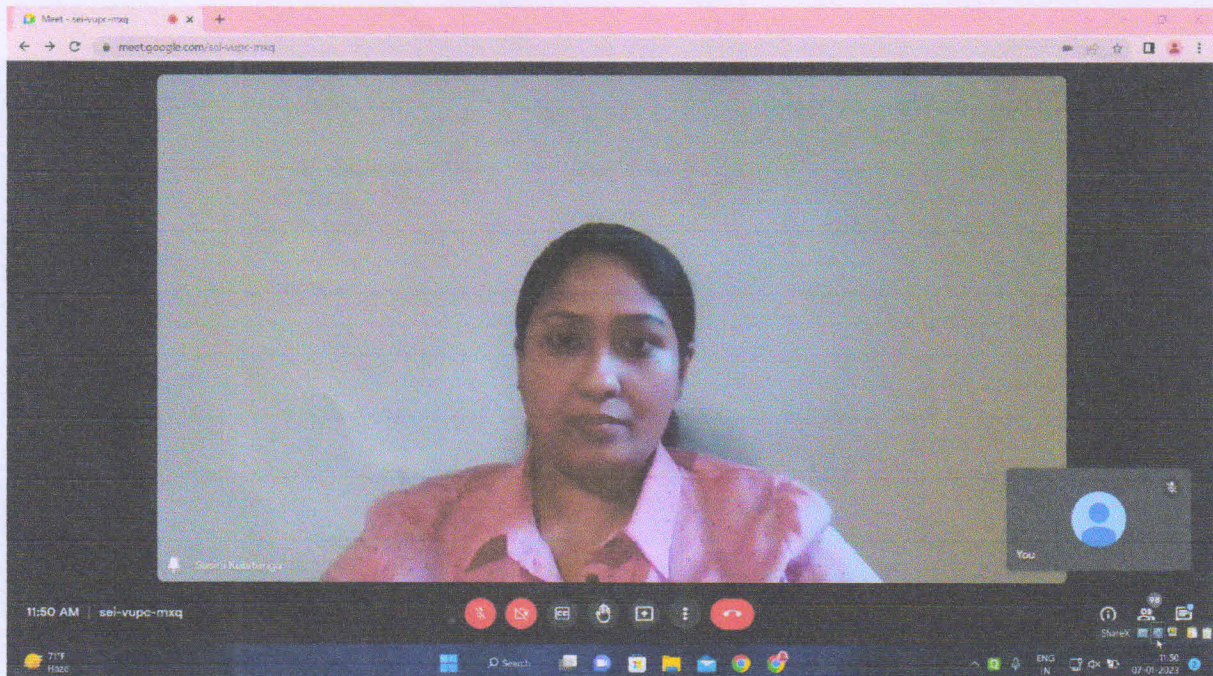

Export Performance and Structure

- In analysing the country's export performance and structure it is noticed that the export base has not been diversified over the years.
- In some respect, Sri Lanka has transitioned from heavy dependence on one historical export, tea, to a modern one garments.
- Such heavy reliance on one industry can be a source of vulnerability, especially as the international trade in garments has historically - though less so now - been the subject of regulation.
- The obvious gap in Sri Lanka's exports has been its failure to penetrate the East Asian global production network concentrated on the electronic industry.

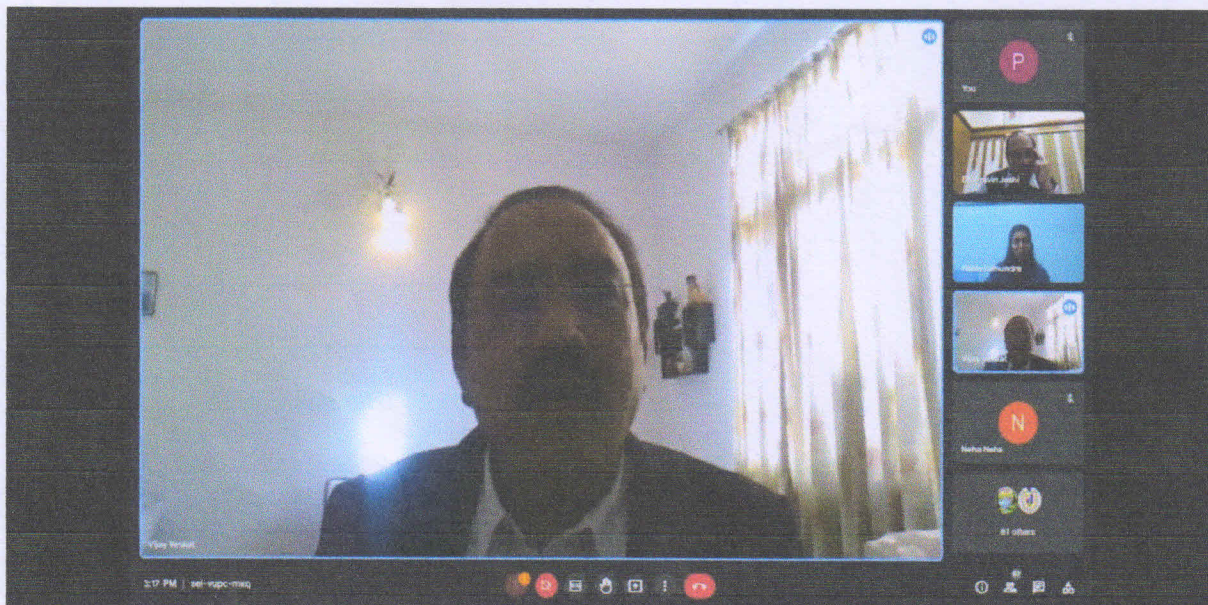
