**Date and Time: 12<sup>th</sup> February, 2022 from 11:00 am to 1:00 pm.**

1. To create awareness about Union Budget among students.
2. To make the students understand the very reason behind the existence of Budget
3. To enhance the knowledge of students about Budget and its structure.
4. To understand why and how the budget is important to the Government and public in general.
5. To analyse the relevance of budget in country's growth and development.
6. To make the students understand the pros and cons of the budget of the year 2022-23.

### **Highlights: -**

1. The session was conducted in online mode.
2. The guest speaker was introduced and welcomed by Ms. Dipawali Randive, Assistant Professor, Prerna College of Commerce, Nagpur.
3. Mr. Rahul Kharwade, Assistant Professor, Prerna College of Commerce, enlightened the students with an introductory speech in which he introduced the



basic idea and structure of the Union Budget. He gave a brief overview of the central government's revenue and expenditures.

4. The guest speaker Mr. Gaurav Kaushik, Chartered Accountant, M/s Rathi Kaushik & Associates, started his talk with the definition of budget.
5. He also explained different types of budgets like State Budget, NMC Budget, etc.
6. The speaker enlightened the students on the importance and relevance of the budget.

8. The speaker elaborated the different aspects of the Union budget and also explained the role of budget in the development of a country.
9. Mr. Gaurav Kaushik explained the different sources of income for the Government and how the funds are channelized for the development of the Nation.
10. He explained the vital role of the Finance Ministry and the contribution of other departments in the preparation of the Budget.

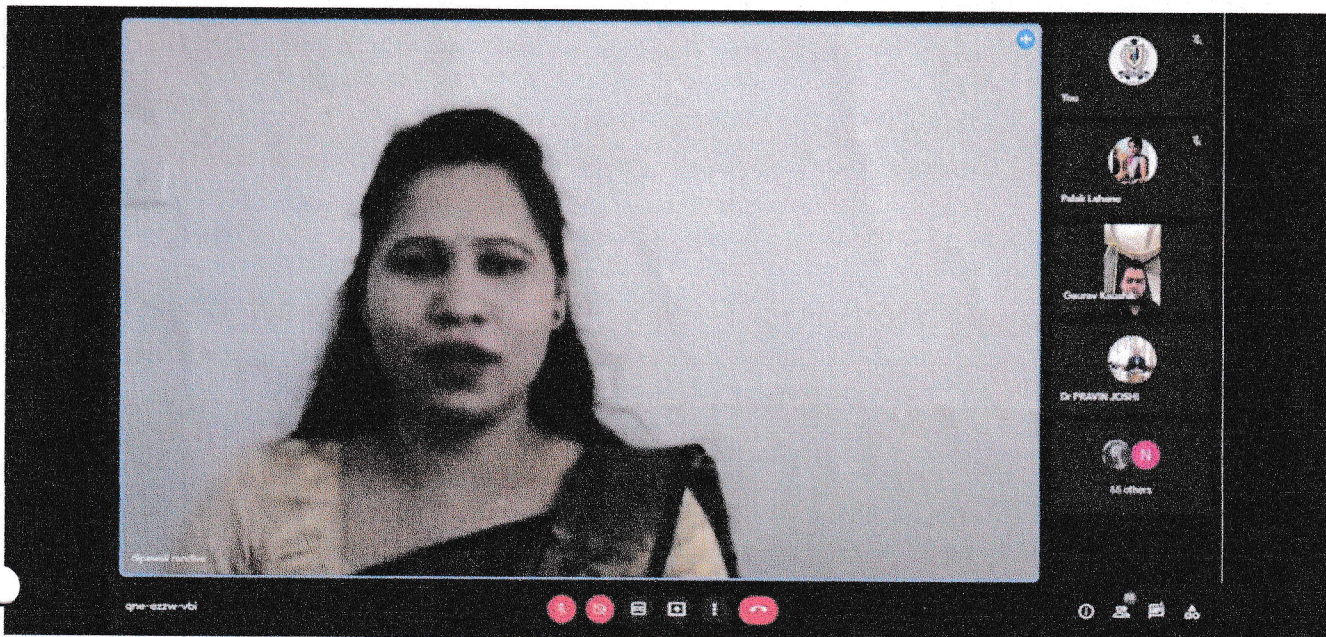



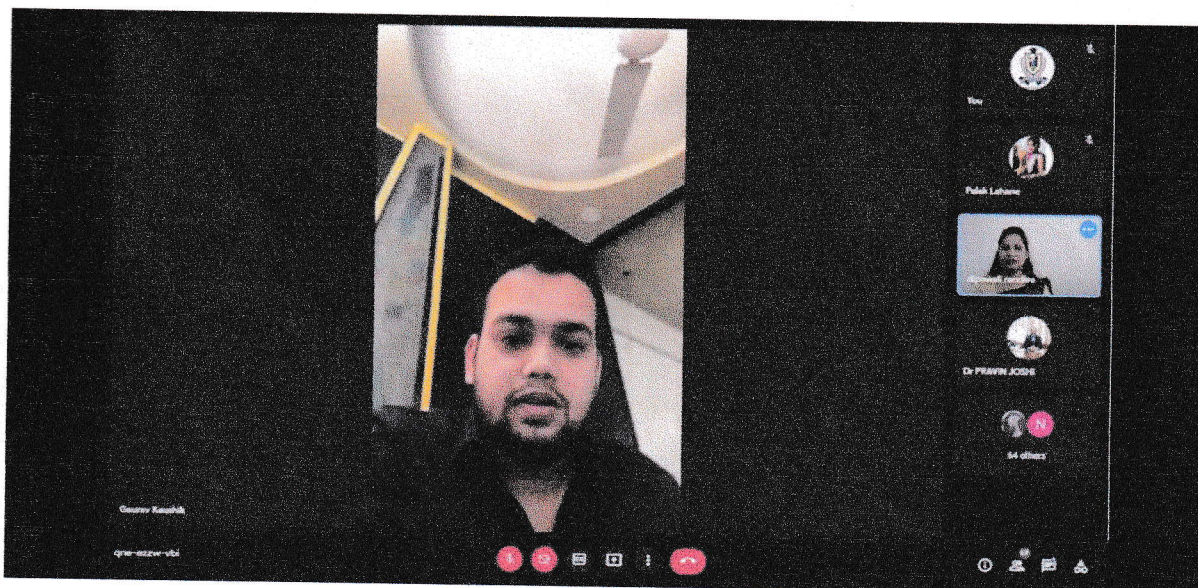


## Budget at a glance by Mr. Rahul Kharwade.



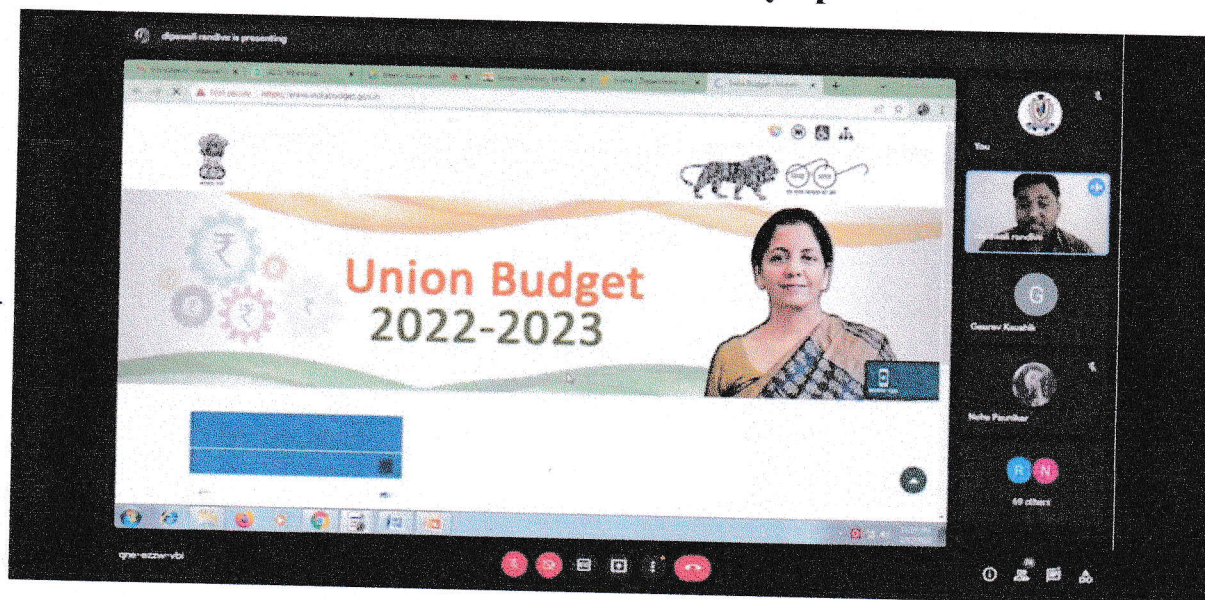
