2. To review the situation of Academic/administrative complaints.




8. Coordinator declared the meeting is adjourned.



Action Taken Report (ATR)

ATR of the previous meeting was presented by the coordinator during the meeting on 19/01/2023.

1. In order for students to effectively study and complete the unit test on a regular basis, complaints from students over the unit test overlap were addressed by creating a reasonable timetable.
2. A complaint by students regarding some subject teacher addressed by principal to direct the teaching team and requested that the teaching style be changed so that students could comprehend the courses fully and use of latest technology in teaching were made mandatory.
3. The complaints about library and computer labs were raised. As a result, it was determined that all subject teachers should provide study materials in hardcopy unit-by-unit format as well as some eBooks since the teaching is done on a technological platform.
4. The issue of computer lab availability is solved by allowing the use of computer whenever the lab is free, so that student can practice properly.
5. Complaint about the break time were resolved by increasing the time of break between the lectures without effecting the academic qualities.


1. The first issue was reading the minutes of previous meeting.
