### **Highlights: Day: - 1**

1. Ms. Rupali Surve introduced and welcomed the resource person Dr. Adv. Mahendra Limaye
2. On the first day Dr. Adv. Mahendra Limaye explained that The Universal Declaration includes civil and political rights, like the right to life, liberty, free speech and privacy. It also includes economic, social and cultural rights, like the right to social security, health and education.
3. He addressed the four key areas: personal rights, such as freedom and equality; relationship rights, such as nationality and having a family; spiritual and political rights such as the freedom of religion and voting; and economic, social and cultural rights, which cover work, wages, education and social security.

### **Day – 2**

- Ms. Chandani Shahare welcomed and introduced the resource person Ms. Afsha Khan
- Ms. Afsha Khan in her talk explained the correlation between rights and duties and she explained that it cannot be separated from one another.
- She also explained that the State protects and enforces rights and it is the duty of all citizens to be loyal to the state. Thus a citizen has both Rights and Duties.

### **Day – 3**

- Ms. Shraddha Yeole welcomed and introduced the resource person Adv. Nanda Parate.
- Adv. Nandini Parate in her talk explained Different aspects of Human rights.
- she explained that Human rights include the right to life and liberty, freedom of opinion and expression, the right to work and education, and many more.
- Everyone is entitled to these rights, without discrimination.



## Day – 4

- Ms. Poorva Wagh welcomed and introduced the resource person Adv. Deepak Sharma.
- Adv. Deepak Sharma in his talk explained about Education of Human Rights.
- He explained about the learning process that builds up the required knowledge, values, and proficiency of human rights which the objective is to develop an acceptable human rights culture.
- He explained how education of Human Rights benefited to examine their experiences from the human rights point of view enabling them to integrate these concepts into their values and decision-making.

## Day – 5

- Ms. Pooja Gadwe welcomed and introduced the resource person Mr. Tarun Shrivastav.
- Mr. Tarun Shrivastav in his talk explained the concept of rights and Duties under Human rights.
- He explained that Individuals also have responsibilities: in using their human rights, they must respect the rights of others. No government, group or individual person has the right to do anything that violates another's rights.

## Day – 6

- Ms. Pooja Nikhar welcomed and introduced the resource person Dr. Dharmesh Dhawankar.
- He explained that Human Rights takes a systematic and methodological approach to evaluation as part of results-based management.
- He also told that It works towards an evaluation culture built around the needs of users and the impact on rights-holders.
- He also explained that the long-term goal of Human Rights' evaluation function is to make the Office's interventions more relevant, efficient and effective, to have a greater impact and be more sustainable.

## Day – 7

- Ms. Neha Samundre welcomed and introduced the resource person Adv. Sai



Prakash.

- He explained that Human rights are needed to protect and preserve every individual's humanity, to ensure that every individual can live a life of dignity and a life that is worthy of a human being.
- He told that human rights are important because no one should be abused or discriminated against, and because everyone should have the chance to develop their talents. Unfortunately, many people around the world don't have these basic rights and freedoms.
- He also explained the various Ways to Protect & Support Human Rights for People around the World.

### **Day – 8**

- Ms. Bhagyashree choudhari welcomed and introduced the resource person Dr. Amar Singh.
- He explained the two theories related to human rights that dominate contemporary human rights discussion are the interest theory and the will theory.
- He explained that Freedom is the goal rather than the ground of human rights. But freedom is also essentially dependent on others and other cultures. Achieving the conditions for freedom - human rights - is humanity's overriding moral obligation.
- He told that In the modern period, freedom has traditionally been conceived as innate and, hence, as independent of our particular social relations.

### **Day – 9**

- Ms. Leena Kapse welcomed and introduced the resource person ACP Milind Totre.
- He explained that Human rights include the right to life and liberty, freedom from slavery and torture, freedom of opinion and expression, the right to work and education, and many more. Everyone is entitled to these rights, without discrimination.
- He also explained that Cases of violence, murder, torture, rape, child abuse, death due to starvation, death due to dowry, sexual harassment, custodial death have become rampant in the society. The Human Rights of the people have been protected by "The Protection of Human Rights Act, 1993".
- He told that It is constitutional mandate of judiciary to protect human rights



of the citizens. Supreme Court and High Courts are empowered to take action to enforce these rights. Machinery for redress is provided under Articles 32 and 226 of the constitution.

### **Day – 10**

- Ms. Ankita Pathare welcomed and introduced the resource person Dr. Ujwal Lanjewar.
- He explained that In the last 35 years, the human rights movement has been enriched by collective wisdom emerging from the tribal movement, peasant struggles, environmental movement, women's liberation movement, child rights movement, dalit movement and struggles of the differently abled persons.
- He also explained that Social movements refer to deliberate collective action involving revolt, reformation or revolution in the existing social order. This work makes a modest attempt to argue that social movements and human rights are closely linked and all social movements raise, directly or indirectly, questions of basic human rights.

### **Valedictory Function.**

This 10 days certificate course of human rights has been concluded with the valedictory function On 5<sup>th</sup> February 2022.

On this occasion Ms Neha Samundre welcomed and introduced Dr Rajesh Tejania, the hon'ble chief guest of the valedictory function. Dr S. C. ## JADAVPUR UNIVERSITY PROTEST, 2014

On 16 September 2014, demonstrations of students at the administrative building requested an inquiry into the harassment of a female campus student.

Students went on hunger strike, and a surge of demonstrations sparked amid police violence in the early hours of Sept. 17.

This ended with almost 100 students who declined to graduate in the college and the VC was burned.

Demonstrations of unity with students started in India. In January 2015, the VC Abhilash Chakrabarti resigned from his post after four months of continuous agitation.






